### **Eligibility**

1. The applicant must be an employee or natural born or adopted child of an employee of PHSEK, TBA, or Fugate Enterprises for at least one year prior to application.
2. The applicant must be enrolled for 2016-2017 as a) a Full-Time or Part-Time student in an undergraduate-level degree program at an accredited college or university; or b) a Full-Time or Part-Time student in a Vocational-Technical program at a Vo-Tech school.
3. The applicant must demonstrate and maintain a 2.0 Grade Point Average in high school or have a GED. Applicants must submit a partial transcript with this scholarship application and a final transcript by July 1, 2016 or their GED transcript.
4. The applicant must be actively employed by PHSEK, TBA or Fugate Enterprises at the time of application or the applicant must be a natural born or adopted child of a PHSEK, TBA or Fugate Enterprises employee who has been employed full-time for at least a year prior to 1/1/16.

### Active Participation Criteria

Applicants must meet a minimum of 1 criteria to be considered eligible for scholarship money

1. Currently employed by PHSEK, TBA or Fugate Enterprises and also employed full-time for at least one year prior to 1/1/16.
2. Parent(s) are currently employed and have been employed full-time by PHSEK, TBA or Fugate Enterprises for at least one year prior to 1/1/16.
